### **Value of Scholarship**

1. **RM18,000 per scholarship per annum** (UC Fees + Allowance).
2. The tenure of the scholarship is only for the **normal duration** of studies.

### **Terms & Conditions**

1. This scholarship is **renewable from year to year** at the absolute discretion of Croesus IT Solutions Sdn Bhd and subject to satisfactory performance. A written application accompanied by certified true copies of current examination results must be made for each successive year, and supported by the Dean of Faculty concerned.
2. During the course of study, the scholarship recipient is not allowed to hold concurrently any other forms of financial assistance.
3. The scholarship recipient is required to maintain a CGPA of 3.000 every semester.
4. The scholarship has a **service bond of one (1) year**, whereby the scholarship recipient graduate has to serve in Croesus IT Solutions Sdn Bhd or its partner companies upon graduation.
5. **Internship/Practical Training** at Croesus IT Solutions Sdn Bhd or its partner companies is **compulsory**. No allowance will be paid during the internship period.
