1. Programme of Studies

- 1.1. Bachelor of Construction Management and Economics (Honours) *Year 2 (July) semester*
- 1.2. Bachelor of Quantity Surveying (Honours) *Year 2 (Nov) semester*

2. Eligibility Criteria

- 2.1. Citizen of Malaysia
- 2.2. Achieved minimum CGPA of **3.000** in the latest TAR UMT examinations.
- 2.3. **Financially needy** with total monthly income of parents/guardian less than RM10,000.
- 2.4. Active in extra-curricular activities, with **leadership** characteristics.

3. Value of Scholarship

- 3.1. **Full fees** for the balance of the bachelor degree's studies.
- 3.2. **Monthly living allowance** of RM1,200 during the duration of sponsorship.
- 3.3. The tenure of the scholarship is only for the **normal duration** and **normal structure** of studies. Any deferred or repeat subjects and / or extended semesters are **excluded** from this sponsorship.

4. **General Terms and Conditions**

- 4.1. The scholarship is **renewable** every semester at the absolute discretion of Inta Bina Sdn Bhd and subject to scholarship recipient's satisfactory performance.
- 4.2. The scholarship recipient is required to maintain a CGPA of **2.800** and above at every semester throughout the sponsored period.
- 4.3. Scholarship recipient is required to update Inta Bina Sdn Bhd his / her achievements every semester by **written** communication, together with the following documents:
 - 4.3.1. Certified true copy of latest examination results
 - 4.3.2. Semester fee / invoice from TAR UMT for the new Semester
- 4.4. The semester fees will be paid through the Bursary of TAR UMT.
- 4.5. Monthly living allowance will be credited into scholarship recipient's bank account by Inta Bina Sdn Bhd.
- 4.6. During the sponsorship period, the scholarship recipient is not allowed to hold concurrently any other forms of financial assistance or employment/income.
- 4.7. Scholarship recipient is required to submit proof of withdrawal from other financial bodies, if any.
- 4.8. Any admin or premature termination charges from the previous financial bodies shall be **excluded** from this sponsorship.
- 4.9. **Internship / practical training** at Inta Bina Sdn Bhd or its affiliates is **compulsory**. A **monthly internship allowance** of RM500 shall be granted during the period of internship / practical training.
- 4.10. The scholarship recipient is **obligated to serve** Inta Bina Sdn Bhd or its affiliates upon completing the programme of studies with relevant positions available. The bonding ratio is 1:1, eg. if the programme sponsored is 2 years, bonding shall be 2 years.
- 4.11. Inta Bina Sdn Bhd may at its absolute discretion terminate this award if the scholarship recipient:
 - 4.11.1. Fails to abide by the terms and conditions of this scholarship; or
 - 4.11.2. Furnished information in his/her application during the interview is found to be untrue, misleading or inaccurate; or
 - 4.11.3. Fails to obtain satisfactory results in the programme of studies; or
 - 4.11.4. Found guilty of serious misconduct during the period of studies; or
 - 4.11.5. Discontinues or abandons his/her studies before the programme is completed; or
 - 4.11.6. Fails to complete the programme within the stipulated duration of the year of studies; or
 - 4.11.7. Wishes to withdraw from this scholarship for whatever reasons
- 4.12. The decision of Inta Bina Sdn Bhd shall be final and conclusive and shall not be questioned in any way whatsoever
- 4.13. In the event the scholarship award is terminated, the scholarship recipient is required to pay back the full scholarship amount disbursed to him/her, within 60 days from termination of award.

5. **Application**

- 5.1. Applicants may download the application form from TAR UMT website at the beginning of every July semester (Bachelor of Construction on Management and Economics) and November semester (Bachelor of Quantity Surveying).
- 5.2. Completed application with relevant documents must be emailed to the company's **mailbox** admin@intabina.com on or before the closing date stipulated in the application form.
- 5.3. Only shortlisted candidates will be required to attend an interview with Inta Bina Sdn Bhd.
