Programmes of Studies

- Bachelor of Hospitality Management (Honours)

Eligibility Criteria

- Available for Malaysian citizens only;
- Be enrolled to the above-mentioned programme of studies with minimum CGPA of 3.3000 in Foundation / Diploma / STPM or equivalent;
- Total combined income of parents / guardian not more than RM5000 per month; and/or
- Active participation in extra-curricular activities.

Value of Scholarship

- RM12,000 per annum and monthly living allowance of RM1,000 for the duration of programme.
- The tenure of the scholarship is only for the normal programme duration.

Internship & Service Bond

- **Internship / practical training** at Plenitude's group of hotels is **compulsory**.
- Scholarship holder must enter into Scholarship Agreement with Plenitude Berhad and is required to perform a **Service Bond** in Plenitude Berhad or any of its subsidiaries upon graduation. The applicable period for the Service Bond shall be determined according to the total duration of the Scholarship was provided (e.g. 3 years program = 3 years service bond)

Other Terms & Conditions

- Applicants must not be presently holding other scholarship/loans with bonding period from any other corporations / organizations / institutions or governmental body.
- During the scholarship period, the scholarship recipient is not allowed to hold concurrently any other forms of scholarship / financial assistance from any other corporations / organizations / institutions or governmental body.
- The scholarship is renewable every semester at the absolute discretion of Plenitude Berhad and subject to satisfactory academic performance.
- The scholarship recipient is required to maintain a minimum **CGPA of 3.0000** every semester.
- The decision of Plenitude Berhad shall be final and conclusive and shall not be questioned in any way whatsoever.
