Education Malaysia Global Services (EMGS) and Immigration Charges

Charges for Student Pass, Visa, Personal Bond and any other processing fees and charges related to medical screening, medical insurance, etc. will be borne and paid by the international student.

Estimated first year payment for the EMGS and Immigration Charges is approximately RM2,500 to RM4,200/USD560 to USD950². Student pass is subject to annual renewal and the charges are approximately RM750 to RM800/USD170 to USD180² per annum.

² The amount (included SST 8%) will vary according to the country of origin.
